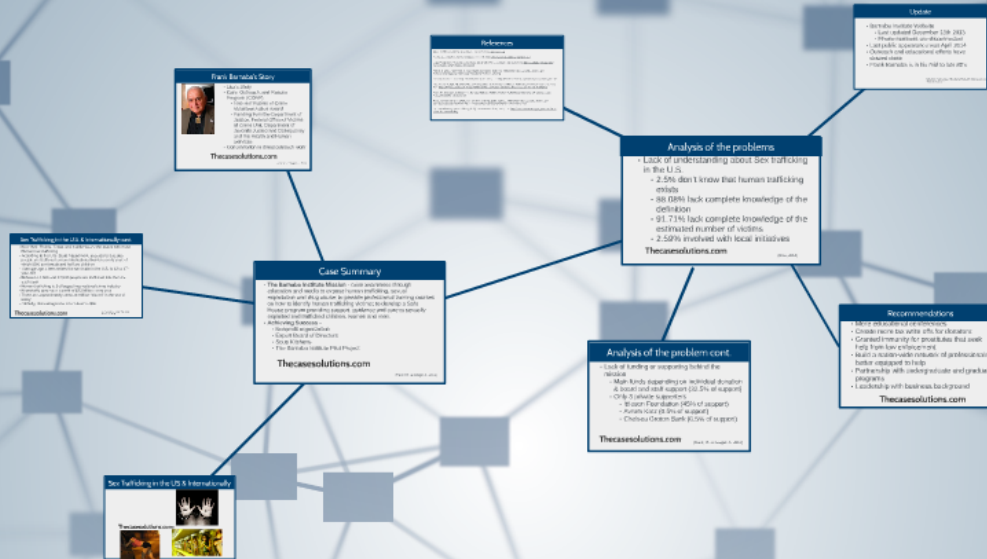


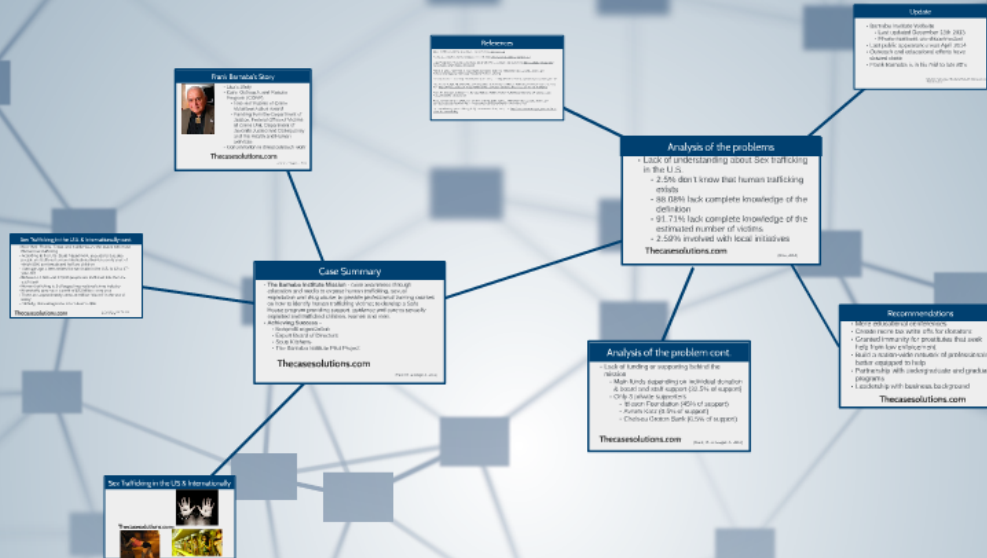

# Sex Trafficking in the U.S. & Internationally cont.

- New York, Florida, Texas, and California are the states with most Human sex trafficking
- According to the U.S. State Department, 600,000 to 800,000 people are trafficked across international borders every year, of which 80% are female and half are children
- Average age a teen enters the sex trade in the U.S. is 12 to 17-year-old
- Between 14,500 and 17,500 people are trafficked into the U.S. each year
- Human trafficking is 3rd largest international crime industry
- Reportedly generates a profit of \$32 billion every year
- There are approximately 20 to 30 million “slaves” in the world today
- Globally, the average cost of a “slave” is \$90

# Analysis of the problems

- Lack of understanding about Sex trafficking in the U.S.
  - 2.5% don't know that human trafficking exists
  - 88.08% lack complete knowledge of the definition
  - 91.71% lack complete knowledge of the estimated number of victims
  - 2.59% involved with local initiatives

# Analysis of the problem cont.

- Lack of funding or supporting behind the mission
  - Main funds depending on individual donation & board and staff support (32.5% of support)
  - Only 3 private supporters
    - Ittleson Foundation (45% of support)
    - Avrum Katz (0.5% of support)
    - Chelsea Groton Bank (0.5% of support)
