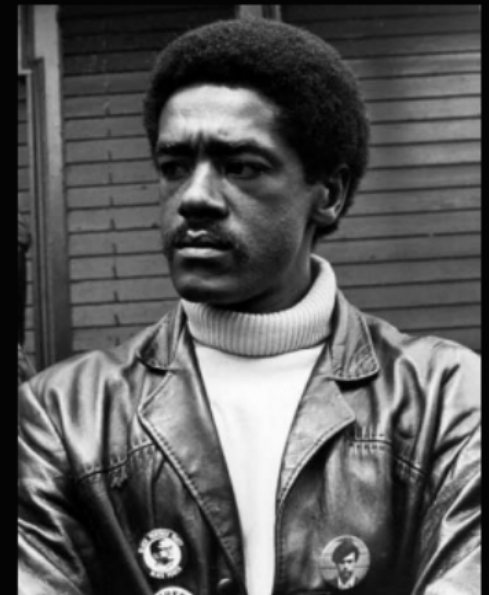
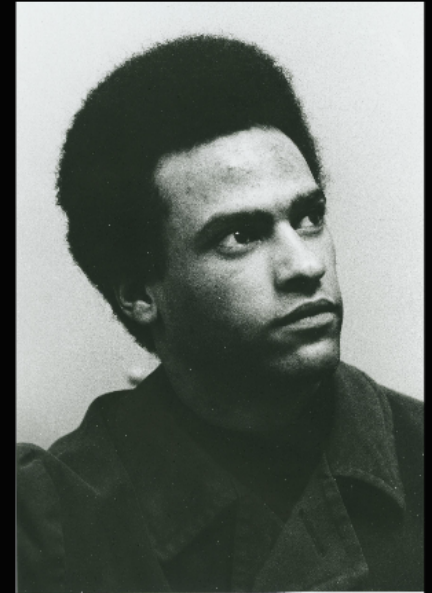
"Anybody who rapes, and plunders, and enslaves, and steals, and drops hell bombs on people... anybody who does these things is nothing but a devil."

# HUEY NEWTON AND BOBBY SEALE

Huey Newton and Bobby Seale had been long time friends who both admired the ideas of Malcolm X and Karl Marx. They both co-founded the Black Panther Party in 1966 because they were upset with the lack of protection in their African-American communities and neighborhoods. In 1967 they both started a newspaper "The Black Panther" to spread their ideas even more. By 1968 their ideas did spread to more than half of the country.



# MULFORD BILL AND THE MARCH ON CAPITAL

- They then began to read Executive Mandate 1, but were then forced out.
- President Reagan then signed The Mulford Act which gave the Panthers what they wanted and put them in the national limelight.

-Newton was then sentenced by the local Superior Court to 2-15 yrs.

- Then the "Free Huey" movement began which was fighting for Huey's freedom.

-The case was later brought back to trial, but was then dismissed.
