Read Jennings Case 6.16

Summary of Case

- September 19, 1910 an intruder came in to the house of the Hiller Family (Clarence B. Hiller, Mrs. Hiller and their four children)
- Mr. Hiller was shot twice and killed, and the daughter, according to Murderpedia.org, was molested
- 3 cartridges and 2 led slugs were found, sand in children's bedroom, Kitchen window was suspected entryway of intruder, four fingerprints found in paint on outside railing
- 2:38 AM Thomas Jennings was spotted and questioned by the police. He was injured and they found a loaded revolver on him. (Jennings had just been released on parole from burglary)
- The case was taken to the Illinois Supreme Court.

Now Fingerprint identification was accepted as a means of criminal Identification

Decision

The decision on the case of People v. Jennings founded Thomas Jennings guilty of murder. The evidence that convicted Jennings was the four finger prints lifted from the victims house. These fingerprints were discovered on a freshly painted porch rail outside of the window that Jennings had gone through to enter the house.

Impact of the Decision

- For years, fingerprints have been studied for uniqueness, identification and criminal importance
- Fingerprint identification can be the single most important piece of evidence for solving a crime
- fingerprint impressions have been relied on in ancient cultures as well as European courts of law.
- People V. Jennings established the acceptance of fingerprint evidence as a means of identification in criminal law
- People V. Jennings has continued to influence other criminal courts throughout the history of America that involve fingerprint analysis
