Stowe and Helper: Literary Incendiaries

- Harriet Beecher Stowe-wrote Uncle Tom's Cabin
 - She wanted to awaken the North to the evils of slavery
 - Help start and win the Civil War
 - caused northerners to not enforce the Fugitive Slave Act
 - Popular abroad, especially in Britain and France.
- The Impending Crisis of the South -written by Hinton R. Helper
 - tried to prove that poor whites suffered most from slavery
 - fueled planter elite's fears that non-slaveholders would abandon them

The North-South Contest for Kansas

- Popular sovereignty gone wrong
- There were actually only 2 slaves among 107,000 people that lived in Kansas
- Fight over “an imaginary Negro in an impossible place”
- On election day, proslavery Missourians crossed the border and voted----> Pro-slavery government in place.
- In reaction to the illicit voting, abolitionists established their own government in Topeka.
- In reaction to the establishment of the rebel government, pro-slavery raiders shot up and burned part of Lawrence, Kansas - a free city
- Choice for Kansans - one illegal government or one based on fraud.

Old Buck vs. The Pathfinder

- 1856-- Democrats met in Cincinnati to nominate their presidential candidate.
- As both Pierce and Douglas were tainted by their affiliation with the Kansas-Nebraska Act, the delegates nominated Pennsylvanian lawyer, James Buchanan.
- Enthusiastic Republicans nominated Captain John C. Frémont (nicknamed “The Pathfinder of the West”).
- Particular issues between the two parties included the extension of slavery (denounced by Republicans) and the emphasis on popular sovereignty (favored by Democrats).
- Increased xenophobia arose as a result of the recent influx of Irish and German immigrants, causing nationalistic “nativists” to form of the American party, a.k.a. The Know-Nothing party
- Mudslinging was a highly prevalent tactic used by both parties.

The Electoral Fruits of 1856

- Buchanan won the presidency.
- Why did the advantageous Republicans lose?:
 - 1) Frémont could not be trusted as his honesty, capacity, and sound judgement were questioned by voters
 - 2) Southern “fire-eaters” violently threatened to secede if a “Black Republican” became president.



The Dred Scott **BOMBshell**

- Dred Scott vs Stanford
- Lived in Illinois/Wisconsin territory
- Stated Scott could not use courts because he was not a citizen
- Chief Justice Roger B Taney was pro-southern
- 5th amendment, Compromise of 1820 was unconstitutional the whole time.
- Wedge driven in between N & S
- Republicans outrage, state that the ruling is just an opinion
- Southerners happy for victory, but aghast at disobedience of North.
