Robert Larmer States in his article "Whistleblowing and Employee Loyalty".....

-Whistleblowing can be ethical and justified, "...on the basis of a higher duty to the public good(Larmer)"

Ronald Duska discusses loyalty, and whistle blowing. He says that it does not need to be justified because the act of loyalty goes both ways, and companies can not be loyal to an individual, so the act of whistleblowing does not need to be justified in order for it to be ethical (Duska).

Sissala Blok believes it to be unethical because it is a "breach of loyalty to the employer" and it can cause harm, not only to the business but to the person who is "blowing the whistle."
