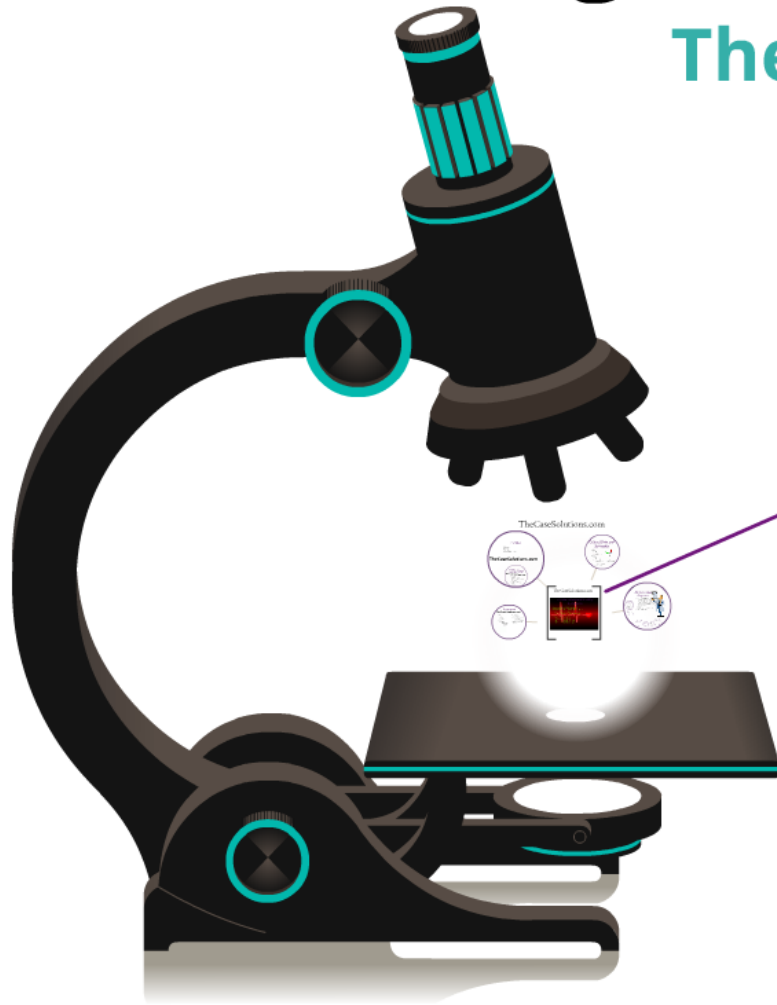

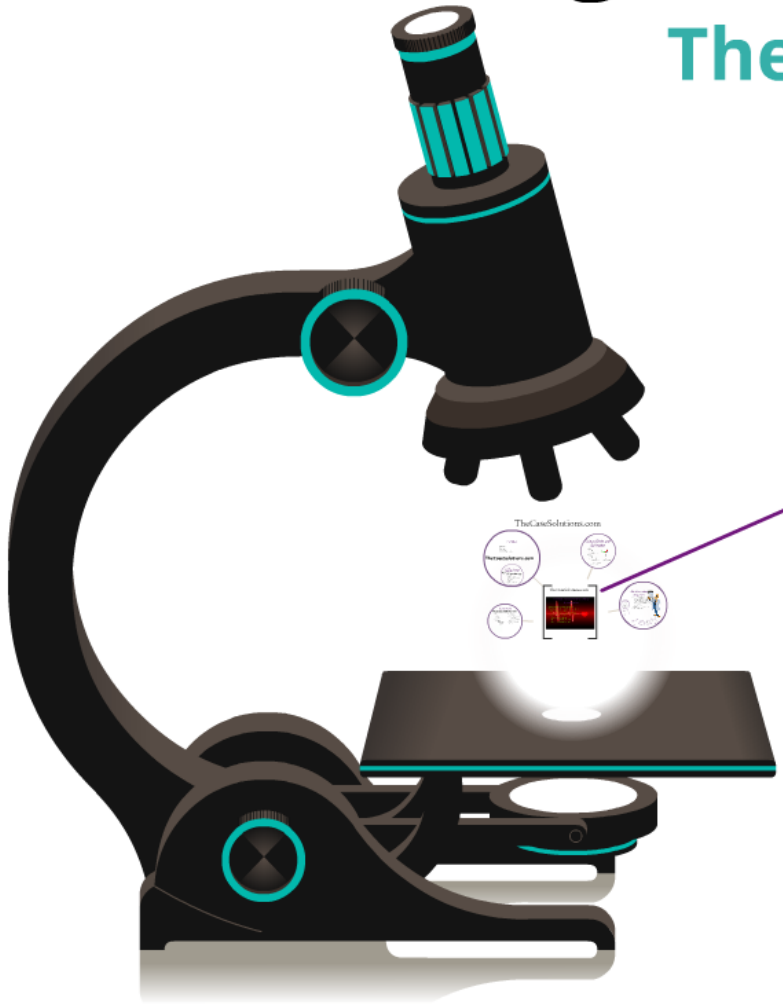

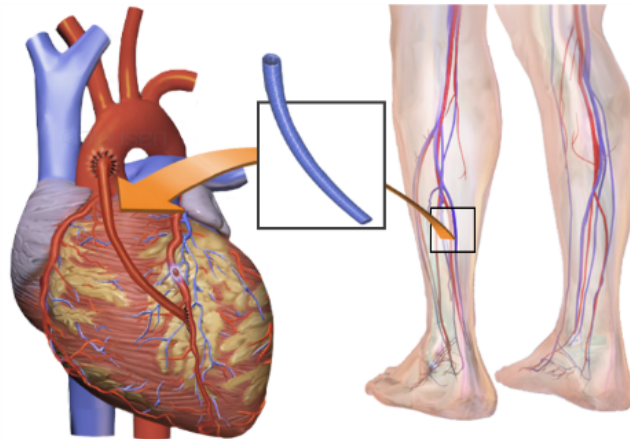

Physical Assessment/Charting by Exception

- Strong heart beat, not +4 bounding pulse
- 18 cm sternum wound, approximately scabbing, no significant drainage/exudate
- T-EFT (1) - no drainage/exudate, no significant drainage/exudate
- Medial aspect of right leg
- Medial aspect of right popliteal
- Medial aspect of right inguinal

Priority Nursing Diagnoses

- Cognitive/Perceptual (Carpenter, 2010)
 1. Knowledge deficit related to low health literacy evidenced by verbalizing having "no idea" about internal ADLs
- Health Perception/Management
- Nutrition/Meal/Intake

Physical Assessment/Charting by Exception

- Strong heartbeat, not +4 bounding pulse
- 18 cm sternal wound, approximated, scabbing, no significant erythema/exudate
- 1-2.5 cm wounds approximated, scabbing, no significant erythema/exudate
 - Medial aspect of right leg
 - Medial aspect of right popliteal
 - Medial aspect of right inguinal
