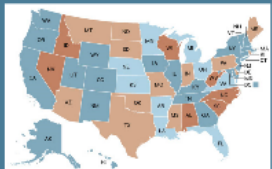

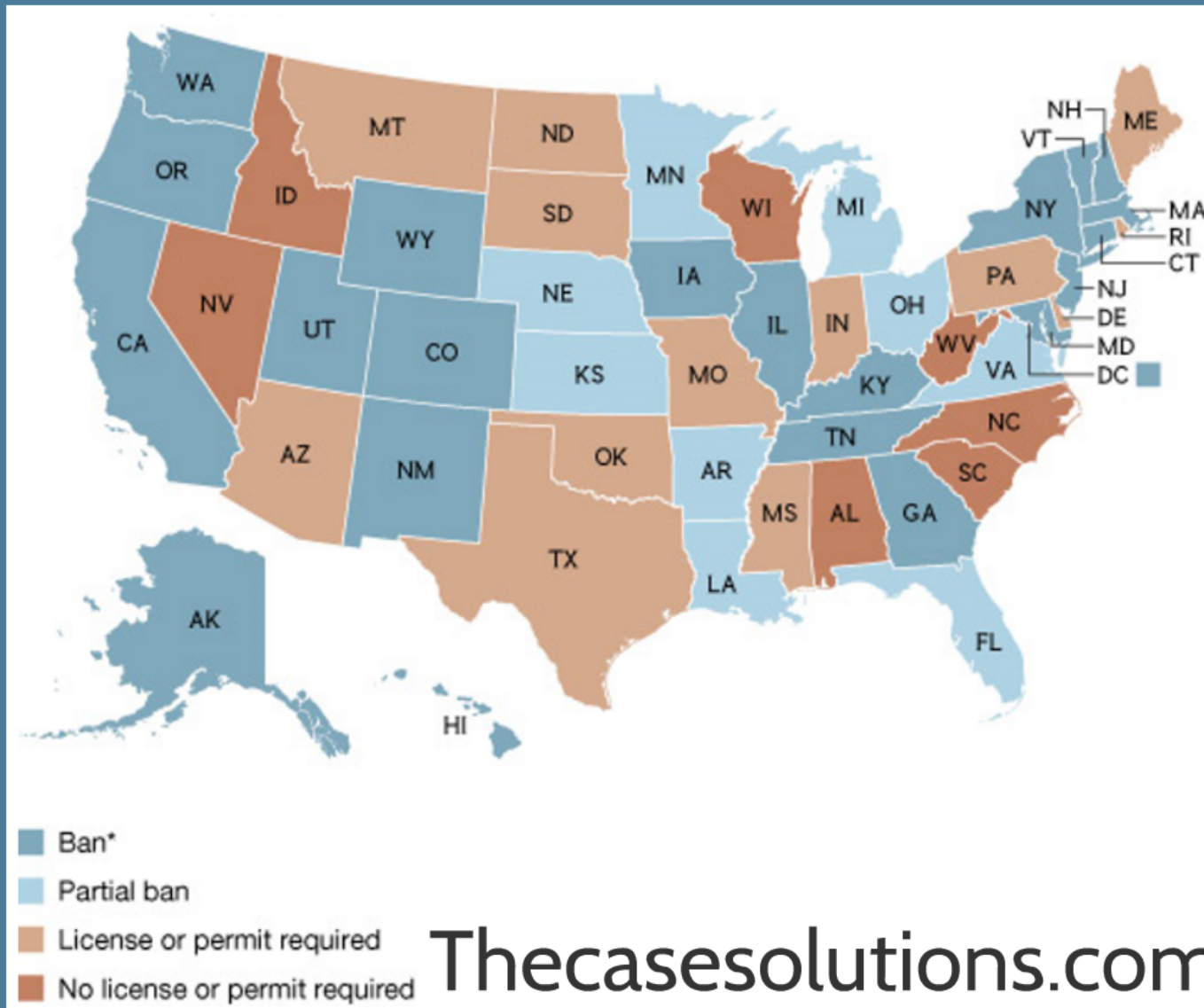


Ohio case.
