



Sycal Ventures Berhad Principles Activities

- Core business: Construction activities (Group's revenue 71%)
- Two newly acquired subsidiaries namely: Sycal Properties S/B and Sycal Resorts S/B
- 3 new development projects: Cheras, Bukit Gambir and Lumut which amounts to RM255 millions of Gross Development Value (GDV).
- Construction projects received either in-house or from external amounted to RM 500 million
- Future or on-going projects located in local small towns provide a latent total GDV of RM 1.2 billion
- Property development activities are one of the main providers of core profit for the Group for the next 5 to 10 years
