

History

The first Hedge Fund was created in 1949 by the doctor in sociology and financial journalist Alfred Winslow Jones.

In the 1990s, hedge funds actually had their take-off, because it during this decade, institutional investors such as insurance companies or pension funds began to invest in hedge funds.



The hedge funds industry began to develop from the 1960s and by 1968 there were around 200 hedge funds.
