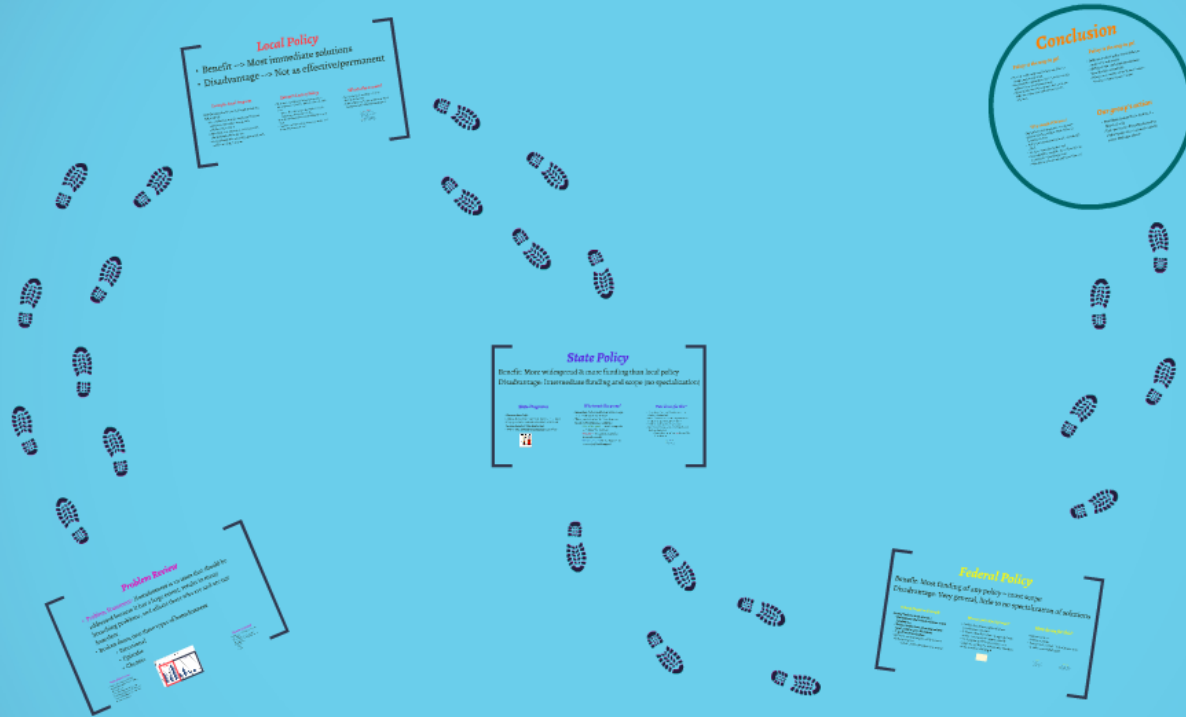

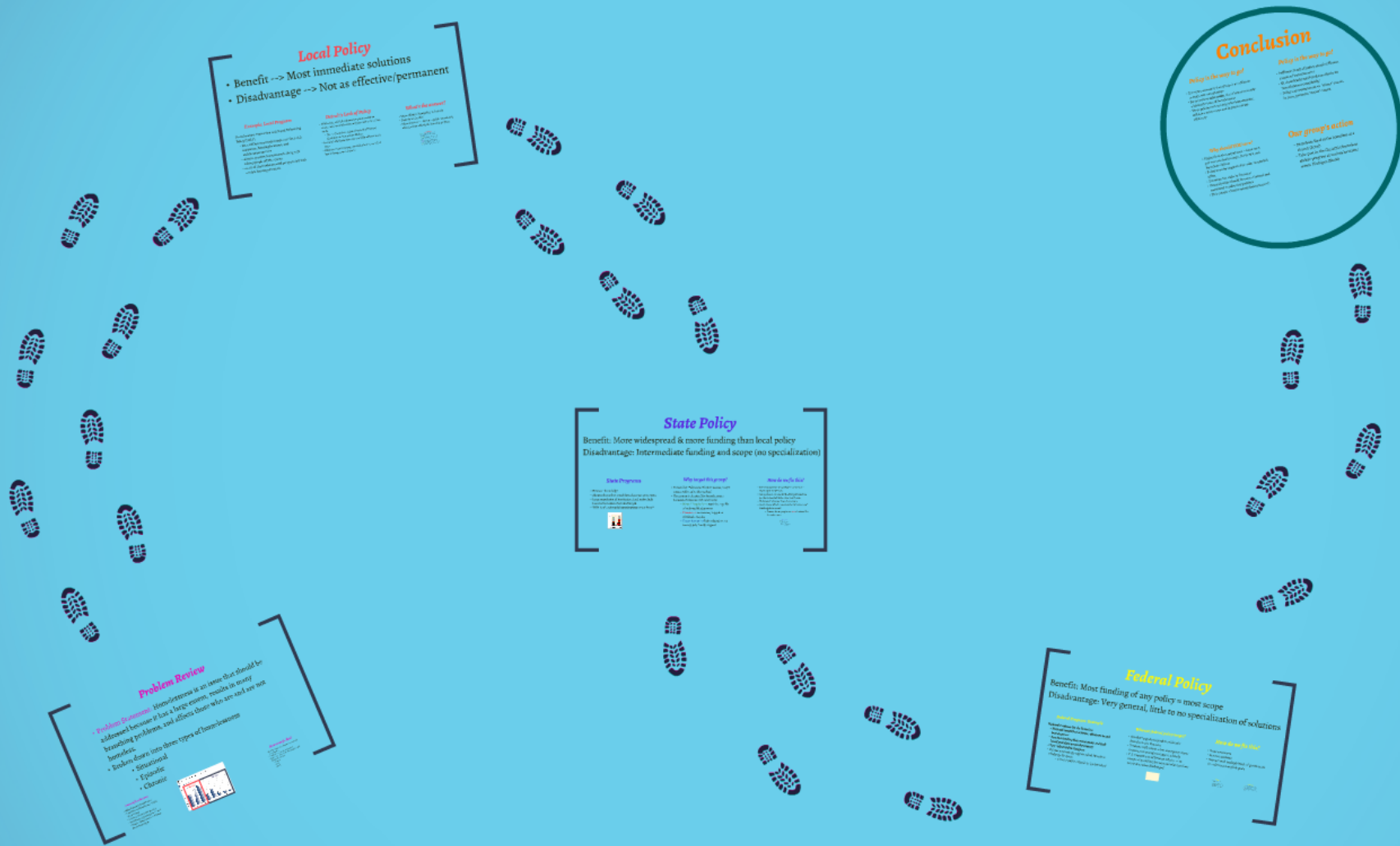

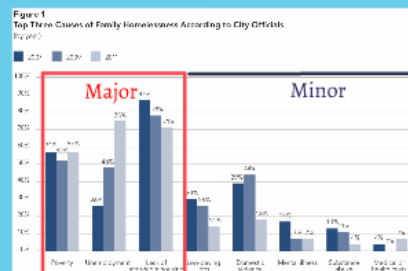


# Problem Review

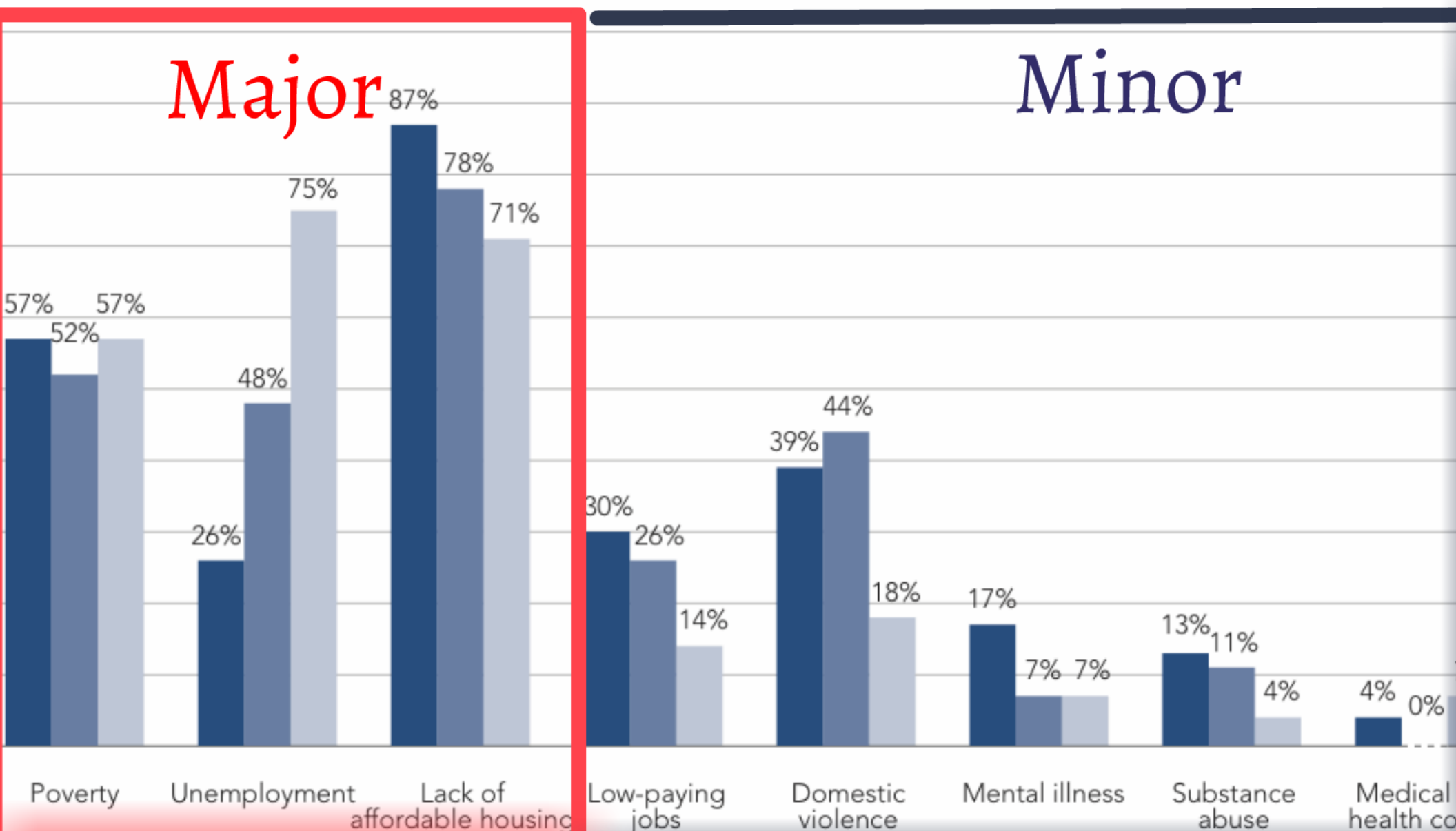

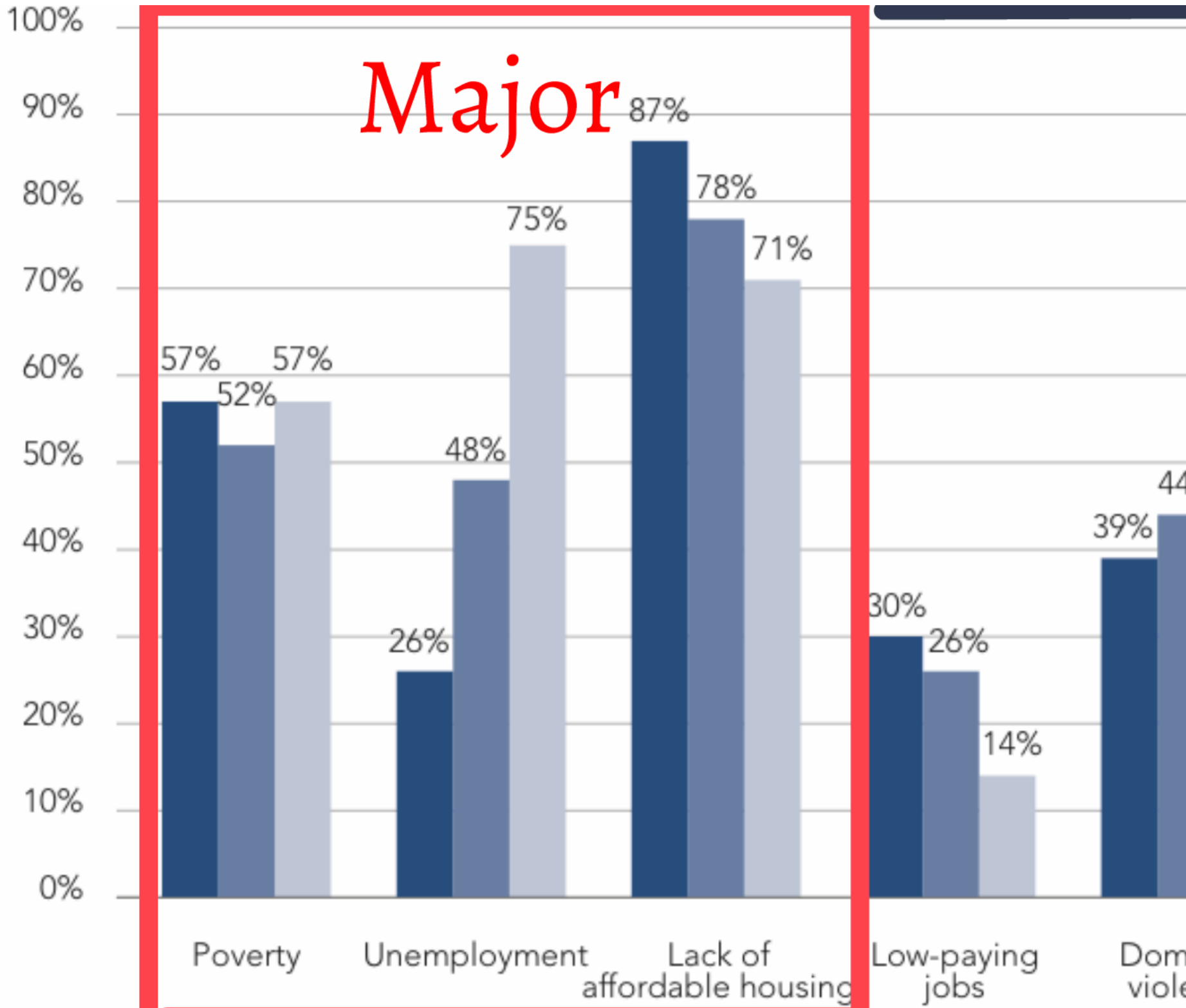

# Five Causes of Family Homelessness According to City Officials

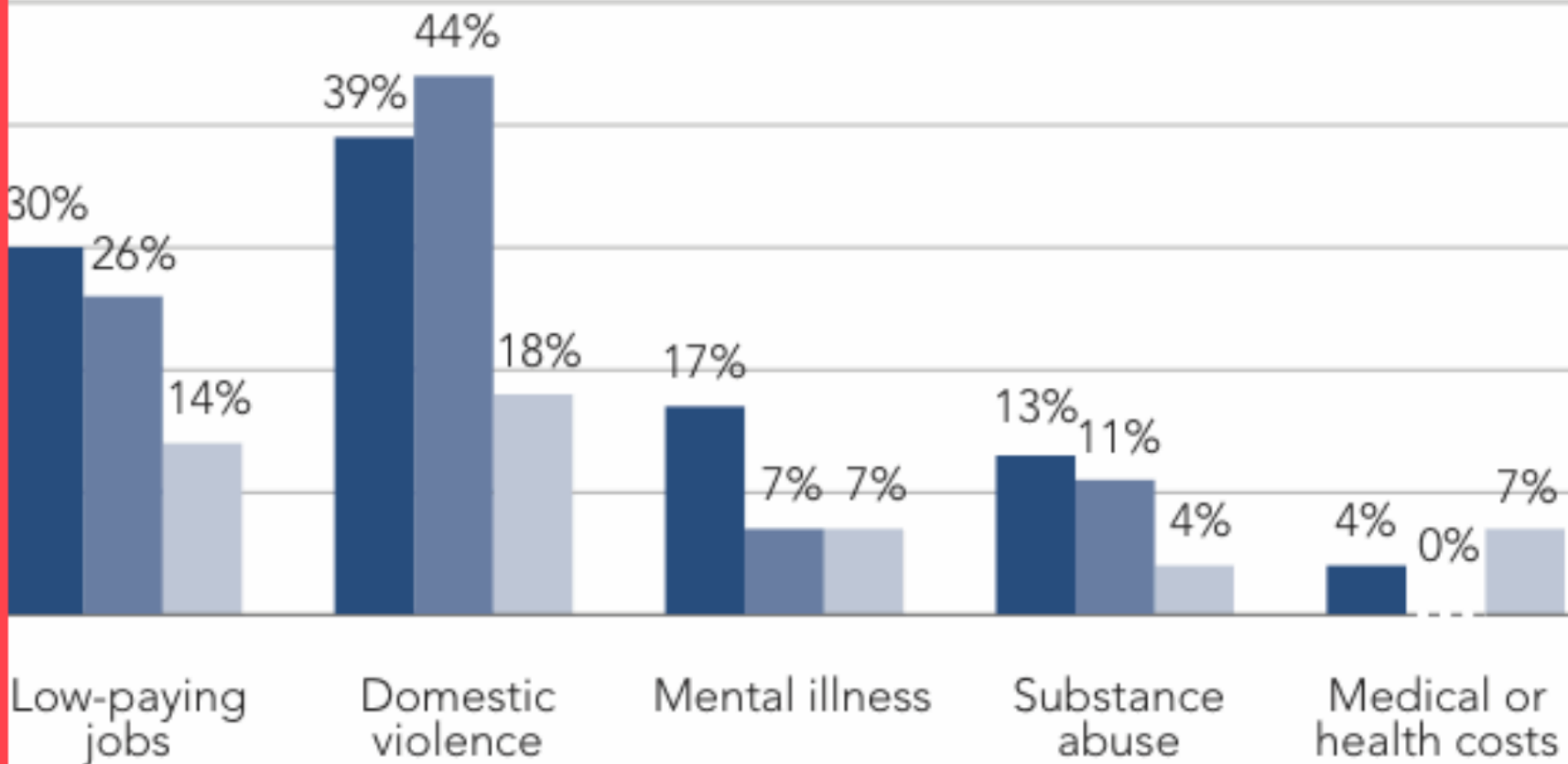
